How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Northwest Bank chooses to share; and whether you can limit this sharing.

Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
